






4TH FLOOR PLAN (UPPER)

TWO BEDROOM + MAID'S ROOM DUPLEX - B UNIT - 02 LEVEL - 03 - 04





THREE BEDROOM + MAID'S ROOM DUPLEX - C UNIT - 03 LEVEL - 03 - 04










3RD FLOOR PLAN (LOWER)


